SYNOPSIS

On 8/15/24 at approximately 17:26 I was dispatched in reference to a call for service that turned to a possible Aggravated Assault.

NARRATIVE

On 8/15/24 at approximately 17:26 I was dispatched in reference to a call for service that turned to a possible Aggravated Assault. Notes on the call stated WHOLE WOMAN HEALTH OF NEW MEXICO OCCD 8/15 0815AM 718 LOMAS BLVD NW CALLER A CITIZEN WAS PRAYING ,,,,PROVIDING PRO LIFE RESOURCES - LISTED MALE WAS TAKING CALLER SIGN LISTED MALE WAS IN HIS VEHICLE MADE A MOTION - TO HIT CALLER WITH HIS VEHICLE :CALLER NOT HURT: CALLER AT HIS HOME 20 25 CALLER CALLER HAS VIDEO FOOTAGE OF INCIDENT.

Upon arrival I spoke with the caller identified as Henry Shaver who stated he was providing Prolife resources outside of whole women's health located at 718 Lomas Blvd around 8:15. when a male later identified as Derek Moore was traveling east on Lomas swerved towards Henry and then back into the roadway. Henry showed me on google maps where he was standing on the east corner of the entrance to the parking lot of whole women's health in the dirt between the curb and the sidewalk. Henry stated he had to jump onto the sidewalk because he felt that if he did not move, he would have been struck by Derek's vehicle. Due to Derek's vehicle being oriented head on with Henry.

Henry then stated Derek drove down a way and parked his vehicle and approached on foot. Henry stated Derek then grabbed one of his prolife signs and walked away. Henry showed me video footage of the theft, a link to evidence.com was provided to Henry. Henry stated he reached out to other church members, and they stated they had similar encounters with an individual with a similar description that matched Derek Moore. Henry was able to provide me with pictures obtained from the other member's encounters.

I then called Derek Moore who stated he was driving and got distracted and accidentally pulled to close to a curb, then swerved back into his lane and continued on his way. Derek stated he saw someone (identified as Henry Shaver) obstructing the sidewalk with a bunch of garbage, so he parked his car. Derek stated he then went and picked up a piece of the garbage to "throw it out". Derek stated Henry followed him and called him a communist. Derek stated Henry was having an "illegal protest and obstructing the sidewalk"

I spoke with the on-call Impact Detective over the phone and told him about this incident. He advised me to forward the report to the Impact Detectives and they would move forward with this case.
